Among the orders received, the most important in strategic and dimensional terms comes from a Chinese customer for the supply of *Test Equipment*.

The acquisition of this order is relevant for ELES as the Asian area is one of the markets in which the company intends to grow and develop its *business* on the basis of the strategic guidelines of the medium - long term.
