SICIT GROUP: RESIGNATION OF AUDITORS

Chiampo (VI), November 24th, 2020 – **SICIT Group S.p.A.** (the "**Company**") announces that Mr. Paolo Ludovici resigned today from his position as Chairman of the Board of Auditors of the Company and Mr. Michele Aprile from his position as Alternate Auditor of the Company, in view of the merger, which will take effect from 1 January 2021, between Studio Ludovici Piccone & Partners and Studio Gatti Pavesi Bianchi, the latter currently being the Company's legal advisor. The above-mentioned resignation will therefore take effect from 1 January 2021 (the "Effective Date").

Pursuant to the Articles of Association and current regulations, from the Effective Date, the Chairman of the Board of Auditors of the Company shall be Mr. Manfredo Turchetti (currently Auditor of the Company) and the Alternate Auditor Mr. Sergio Zamberlan shall take over the position of Standing Auditor until the next Shareholders' Meeting, which will approve the appointments.

Pursuant to the Instructions accompanying the Rules of the Markets organised and managed by Borsa Italiana S.p.A., the Company informs that, on the basis of the information available, neither the resigning Auditors nor the Auditors Manfredo Turchetti and Sergio Zamberlan hold stocks of the Company.
