# SHARE BUY BACK

(the "**Company**" or "**Newlat Food**") announces that, following the authorization of the purchase and disposal of own shares by the Shareholders' Meeting of 29 April 2020, in the period from 2 November to 25 November 2020, the Company bought back a total of 88,700 ordinary shares on the Mercato Telematico Azionario (equal to 0.20% of the share capital) at an average share price of  $\notin$  5.01 and for a total value of  $\notin$  444,772.21.
