## COMMUNICATION ON TOTAL AMOUNT OF VOTING RIGHTS

### pursuant to Article 85-bis, paragraph 4-bis, of Consob Regulation no. 11971/1999

**Saluggia, December 7<sup>th</sup>, 2020** – DiaSorin S.p.A. (“**DiaSorin**” or the “**Company**”) hereby announces that today five shareholders, each of them holding a number of voting rights lower than 3% of the total amount of voting rights – having fulfilled the requirements and conditions under the applicable regulation and the Company By-Laws – obtained assignment of increased voting rights (based on the ratio of two votes for each share) for overall no. 27,408 ordinary shares of the Company.
