### **EXECUTED BUY-BACK PROGRAM**

**Luxembourg - January 05<sup>th</sup>, 2021** – d'Amico International Shipping S.A. (following "DIS" or the "Company") announces today that during the period between December 29<sup>th</sup> and December 30<sup>th</sup> 2020, n. 138,364 own shares (representing 0.011% of the outstanding share capital of the Company) were repurchased on the regulated market managed by Borsa Italiana S.p.A. at the average price of Euro 0.0908 and for a total consideration of Euro 12,559.61.

As at December 30<sup>th</sup>, 2020, d'Amico International Shipping S.A. holds nr. 15,447,896 own shares, representing 1.25% of its outstanding share capital.

The transactions were made and coordinated by an independent equity broker duly engaged for this purpose, Equita SIM S.p.A., in compliance with the Board of Directors resolution of 13<sup>th</sup> of November 2019 and under the authorization to purchase own shares approved by DIS Shareholders' Meeting on 20<sup>th</sup> April 2016 (as reminded by means of a press release issued on 13<sup>th</sup> November 2019).
