Tortona, 25 January 2021. ASTM SpA, a world leader in the management of motorway networks and in the design and construction of large infrastructural works, informs that, as already disclosed to the Market through the official Internal Dealing communications prepared and disseminated pursuant to Law, the top management of the Company, in the persons of the Chairman of the Board of Directors Alberto Rubegni, the Chief Executive Officer Umberto Tosoni, as well as such managers including the Chief Financial Officer Alberto Gargioni, and the Directors of Finance Stefano Viviano, of Accounting and Control Alberto Pernigotti and of Investor Relations & Communications, Lawrence Young Kay, confirm their confidence in the Company and its growth prospects, purchasing a total of **39,564 shares** in the period between 21 January and today.

In this regard, a brief description of the purchases made is hereby provided.

\*(\*) For the sake of completeness, it should be noted that on 21/1/2021 Dr. Kay, through a pension fund, has issued an irrevocable order for the purchase of no. 2,600 ASTM shares which will presumably be executed today.

In the area of concessions, the Group is the second largest operator in the world in the management of motorway infrastructures with a network of approximately 4,600 km of network, of which 1,423 km in Italy, 3,087 km in Brazil through the company Ecorodovias, and 84 km in the United Kingdom through participation in Road Link.*
