Servizi Italia S.p.A. informs that, in the period between 01 February and 05 February 2021 the Company bought on the Milan Stock Exchange, pursuant to the resolution passed at the Shareholder's Meeting held on 28 April 2020 (previously communicated as per Art. 144 bis of Consob regulation 11971/1999), n. 15,500 ordinary shares (corresponding to 0.049% of the Company's share capital) at an average price of Euro 2.2285 per share, for a total of Euro 34,541.15.
