Fulfilment of the Golden Power Condition

Milan, February 10th, 2021 – With reference to the voluntary tender offer (the "**Offer**") launched by ATS Automation Holdings Italy S.r.l. (the "**Offeror**") pursuant to and for the purposes of articles 102 et seq. as well as article 106, paragraph 4, of Italian Legislative Decree no. 58 of 24 February 1998, as subsequently amended and supplemented, as referred to in article 9.1. of the by-laws of CFT S.p.A. (the "**Issuer**"), on all the ordinary, multiple voting and special shares of the Issuer, the Offeror informs that on the date hereof the Presidency of the Council of Ministers has communicated that, on the basis of the results of the preliminary investigation and in light of the determinations made by the Coordination Group for the exercise of the special powers, referred to in Article 3 of the Prime Ministerial Decree of 6 August 2014, at the meeting of 8 February 2021, the Offer does not fall within the scope of applicability of Decree-Law No. 21 of 15 March 2012 (the so-called "golden power" law). Therefore, the Golden Power Condition (as defined in the offer document published on February 5th, 2021) is fulfilled.
