## SICIT GROUP: CONVERSION OF SPECIAL SHARES

Chiampo (VI), February 16th, 2021 – **SICIT Group** (the "**Company**"), listed on the Italian Equities Market (MTA - STAR segment), announces that today the condition provided by Article 6.4 (d)(i) of the Company's Articles of Association, regarding the **automatic conversion of the remaining Special Shares of SICIT Group into Ordinary Shares**, has been met.

Pursuant to the above provisions of the Articles of Association, 195,000 Special Shares will be converted at a ratio of 6 Ordinary Shares for every 1 Special Share held and, therefore, into a total of 1,170,000 newly issued Ordinary Shares of SICIT Group, without any change in the total amount of the share capital.
