# PROCEDURE FOR THE EXERCISE OF SICIT GROUP WARRANTS: UPDATE ON PRESS RELEASE OF MAR. 1<sup>ST</sup>, 2021

Chiampo (VI), March 3<sup>rd</sup>, 2021 - SICIT Group S.p.A. ("SICIT"), following the press release of March 1<sup>st</sup>, 2021, regarding the "Procedure for the Exercise of SICIT Group S.p.A. Warrants", pursuant to Article 3, paragraph 4, of the "Regulation of SICIT Group S.p.A. Warrants" (respectively, the "Regulation" and the "Warrants"), clarifies that the Exercise Ratio of the Warrants, equal to 0.2713, will remain effective from March until the Expiry Term (April 30<sup>th</sup>, 2021).

Pursuant to Article 3, paragraph 7, of the Regulation, the exercise shall in any case be suspended during the Restricted Periods.
