Since the start of the programme, WIIT has bought N° 34,821 ordinary shares (equal to 1.31% of the share capital), for a total value of EUR 5,434,855.00.

Following the purchases made so far, WIIT holds a total of N° 158,463 own shares, equal to approximately 5.98% of the share capital.

The purchases have been carried out pursuant to the provisions of Art. 144-bis of Consob Issuers Regulation no. 11971/99, on regulated markets in accordance with trading methods laid down in market rules, in order to not allow for the direct pairing of buying and selling bids.
