UPDATE ON THE SHARE BUY-BACK PROGRAM

Milan, March 22nd, 2021 – – In relation to the share buy-back program resolved by the Shareholders' Meeting of April 24th, 2020, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period 15th - 19th March, 2021, a total of 150,000 ordinary Amplifon S.p.A. shares, equivalent to 0.066% of the share capital, at an average unit price of Euro 31.983 per share, for a total consideration of Euro 4,797,474.00.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

In reference to the same resolution, the Company has used treasury shares to service the Performance Stock Grant Plan 2011-2020 for a total of n. 12,771,554 shares.

As of March 19th, 2021, Amplifon owned n. 1,909,446 of its shares, corresponding to 0.843% of the Company's share capital and to 0.593% of the total share capital in voting rights.
