## UPDATE ON THE SHARE BUY-BACK PROGRAM

Milan, March  $29^{th}$ ,  $202I - In relation to the share buy-back program resolved by the Shareholders' Meeting of April <math>24^{th}$ , 2020, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in  $22^{nd}$  and  $23^{rd}$  March, 202I, a total of 60,000 ordinary Amplifon S.p.A. shares, equivalent to 0.027% of the share capital, at an average unit price of Euro 3I.9I7 per share, for a total consideration of Euro I.9I5,040.70.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

In reference to the same resolution, the Company has used treasury shares to service the Performance Stock Grant Plan 20II-2020 for a total of n. I2,773,554 shares.

As of March 26<sup>th</sup>, 2021, Amplifon owned n. 1,967,446 of its shares, corresponding to 0.869% of the Company's share capital and to 0.611% of the total share capital in voting rights.
