Milan, 2 april 2021 – Following the press release dated 30 March 2021, Sogefi S.p.A. hereby announces that on 31 March 2021, within the prescribed term, the shareholder YODA Società Semplice, holding n. 2,000,000 ordinary shares SOGEFI, representing 1.665% of the share capital, presented a list of candidates for the appointment of the Board of Statutory Auditors for the years 2021-2022-2023 to be submitted to the Ordinary General Meeting called for 23 April 2021 on first call and for 26 April 2021 on second call.
