PUBLICATION OF THE OFFER DOCUMENT

**Tortona, 2 April 2021** – Pursuant to Article 38, paragraph 2, of the Issuers’ Regulation, NAF 2 S.p.A. (the “**Offeror**”) announces that on the date hereof it has published the offer document (the “**Offer Document**”) approved by CONSOB with resolution No. 21786 of 1 April 2021, related to the voluntary tender offer (the “**Offer**”) pursuant to Articles 102 *et seq.* of the Legislative Decree no.58 of 24 February 1998, as subsequently amended and supplemented (“**CFA**”), launched by the Offeror on No. 66.937.880 ordinary shares (the “**Shares**”) of ASTM S.p.A. (“**ASTM**”, the “**Issuer**” or the “**Company**”), a company with shares listed on the *Mercato Telematico Azionario*, organized and managed by Borsa Italiana S.p.A.

The Offer Document has made available to the public for consultation at:

- (i) NAF 2 S.p.A.’s registered office, in Tortona (AL), Corso Romita No. 10;
- (ii) ASTM’s registered office, in Turin, Corso Regina Margherita No. 165;
- (iii) UniCredit Bank AG, Milan Branch’s registered office (the intermediary in charge of coordinating the collection of acceptances) in Milan, Piazza Gae Aulenti No. 4, Torre C, and the registered offices of the intermediaries appointed for coordinating the collection of subscriptions (*intermediari incaricati del coordinamento della raccolta delle adesioni*);
- (iv) ASTM’s website [www.astm.it](http://www.astm.it).

The Offer Document is also made available to the public on the website of the Global Information Agent ([www.morrowsodali-transactions.com](http://www.morrowsodali-transactions.com)).

In accordance with Article 103, paragraph 3 of the CFA and Article 39 of the Issuers’ Regulation, the Board of Directors of ASTM shall announce to the market, by the day preceding the initial day of the acceptance period, a press release providing all necessary details regarding the Offer and its assessment of the Offer, which will be accompanied by the opinion of an independent expert utilised by the Board of Directors of ASTM.

Considering that the Offer is also conducted in the United States of America, in order to comply with the rules and exemptions provided by US law, a translation in English language of the Offer

Document will be published for the benefit of the holders of the Issuer's shares resident in the United States of America.

Pursuant to Article 40, paragraph 2, of the Regulation issued by CONSOB with Resolution No. 11971 of 14 May 1999, as subsequently amended and supplemented (the "**Issuers' Regulation**"), the acceptance period to the Offer (the "**Acceptance Period**"), agreed with Borsa Italiana, will start at 8:30 (Italian time) on 13 April 2021 and will end at 17:30 (Italian time) on 10 May 2021 (first and last day included), and will therefore consist of 20 trading days (unless extended). Thus, 10 May 2021 will be the last day to adhere to the Offer, unless the Acceptance Period is extended, and without prejudice to the possible Reopening of the Terms (as defined below).

On the fifth trading day following the end of the Acceptance Period, *i.e.* on 17 May 2021 (the "**Payment Date**"), the Offeror will pay to each adhering shareholder a consideration amounting to Euro 25.60, fully paid in cash, for each share tendered to the Offer.

If conditions are met, pursuant to Article 40-*bis*, paragraph 1, letter a), of the Issuers' Regulation, the Acceptance Period will be reopened for five consecutive trading days starting from the trading day following the Payment Date and, therefore, unless the Acceptance Period is extended, for the trading sessions of 18, 19, 20, 21 and 24 May 2021 from 8:30 to 17:30 (the "**Reopening of the Terms**"). In case of Re-opening of the Tender Period, the Price related to the shares tendered in the Offer during the Re-opening of the Tender Period will be paid on 31 May 2021 (unless extended).
