Forlì, 9 April 2021 – Unieuro S.p.A. (MTA: UNIR) announces that, following the execution of an agreement aimed at terminating by mutual consent the employment relationship, Mr. Italo Valenti will leave the office of Chief Financial Officer and of Executive in charge of the preparation of the company's accounts, as well as his office as *investor relator* of the Company. Italo Valenti is going to pursue other professional opportunities, effective as from May 31, 2021.

Italo Valenti will maintain its duties and responsibilities until that date in order to support the Board of Directors in approving the consolidated financial statements and the draft statutory financial statements as at 28 February 2021.

Unieuro expresses its heartfelt thanks to Italo Valenti for his professional contribution and professionalism demonstrated over the years and wishes him the best success for the continuation of his career path.

The Company has already started the search for a successor with the same high profile, so as to allow a smooth handover in an organization-wise seamless continuity.

On the basis of the information available to the Company, Italo Valenti currently holds 3,288 Unieuro ordinary shares and 108,718 subscription rights vested pursuant to the "Long-Term Incentive Plan 2018-2025" and currently fully exercisable.
