With reference to the other items of the Agenda of the Shareholders Meeting of the Company regarding the renewal of Board of Directors, the shareholder TGH S.r.l. proposed to the Shareholders Meeting:

- (i) To fix in 11 the number of members of Board of Directors;
- (ii) To fix in 3 years until the Shareholders Meeting convened for the approval of financial statement on December 31, 2023, the duration of the new Board of Directors;
- (iii) To appoint the candidate Mr. Nerio Alessandri as Chairman of the Board of Directors;
- (iv) to determine (a) the remuneration of the Board of Directors, for the entire duration of the mandate, in a total maximum amount of Euro 9,500,000 (nine million five hundred thousand), gross of withholding taxes, in addition to the reimbursement of expenses incurred for the office, included in this total amount the remuneration for directors with particular offices, which will be determined by the Board of Directors pursuant to art. 2389, paragraph 3, of the Italian Civil Code also with reference to the remuneration for the appointment and participation in the committees established within the Board of Directors itself, excluding from this total amount any remuneration to be paid by virtue of any future incentive plans and (b) the minimum remuneration amount for each Director, included in the aforementioned maximum amount, equal to Euro 25,000 (twenty five thousand) gross per year, without prejudice to the additional remuneration for Directors with particular offices.
