Having joined Fiat in 1998, he has gradually expanded and strengthened his skills in the Finance field by working in various companies of the Group, both in Italy and abroad. From 2006 to 2008, Pacini gained significant experience in the consumer electronics sector as Chief Accounting and Tax Officer of UniEuro / Dixons Group, later returning to Fiat Chrysler Automobiles, first as CFO of Abarth and, most recently, as Car Business Finance Director - EMEA. Lastly, in 2017 he moved to Fiera Milano, listed on the STAR segment of the Italian Stock Exchange, assuming the role of CFO.
