- **PEROTTI MASSIMO**, born in Turin on 26 October 1960, domiciled for purposes of the office at the aforementioned address, who declares me that he is acting here as Chairman of the Board of Directors and legal representative of the company "**SANLORENZO S.p.A.**", with initials "**SL S.p.A.**", with registered office in Ameglia at via Armezzone no. 3, share capital of €34,500,000.00 fully paid-in, enrolled in the Companies' Register of the Chamber of Commerce, Industry, Crafts and Agriculture of Riviera di Liguria - Imperia La Spezia Savona with the following registration number and tax code 00142240464, VAT number 01109160117, in accordance with the powers delegated to him by virtue of the current By-laws, a company with shares traded and managed by "Borsa Italiana S.p.A.", an Italian citizen and of Italian nationality, of whose personal identity, qualification and powers I, as Notary, am certain.

Mr Massimo Perotti takes the floor and, pursuant to Article 11.2 of the By-laws, requests that I, as Notary, draft the minutes of the Ordinary Shareholders' Meeting.

Firstly, the Chairman extends a warm welcome to all attendees and assumes the chair of the Shareholders' Meeting pursuant to Article 11.1 of the By-laws. As a preliminary matter, he notes that the Company has chosen to exercise the option envisaged by Article 106 of Italian Legislative Decree no. 18 of 17 March 2020, containing "*measures to strengthen the national health service and provide economic support for households, workers and businesses related to the epidemiological emergency from Covid-19*" (the "**Cura Italia Decree**") converted into law, as amended, with the Conversion Law no. 27 of 24 April 2020, and as extended by effect of Article 3, paragraph 6, of Italian Legislative Decree no. 183 of 31 December 2020, converted into law, as amended, by Law no. 21 of 26 February 2021, to include in the notice of call that:

- participation to the Shareholders' Meeting by those holding voting rights is arranged solely through the designated representative pursuant to Article 135-*undecies* of Italian Legislative Decree no. 58 of 24 February 1998 (Consolidated Law on Finance, "TUF"), identified in the Company for Trusts "**SPAFID S.p.A.**", with registered office in Milan ("**Spafid**" or the "**Designated Representative**");

- directors, statutory auditors and other entitled parties, other than those holding voting rights (who must grant proxy to the designated representative) can attend the Shareholders' Meeting by means of telecommunications that guarantee their identification, participation and exercise of voting rights, without requiring them to be present at the same venue as the Chairman and minutes secretary, pursuant to the aforementioned legal provisions.

Therefore, he acknowledges:

- that Messrs. Massimo Perotti, Marco Viti, Attilio Bruzzese and Mrs. Silvia Guidi and the I.T. technician Mr. Francesco Cabigliera are present at the meeting venue, whilst all other attendees - for whom the Chairman has confirmed identity and entitlement to participate to the Shareholders' Meeting - are attending via audio-video connection and telecommunication means;
- that from the Board of Directors, in addition to the Chairman, Mr. Marco Viti is attending in person and Messrs. Leonardo Luca Etro, Carla Demaria, Cecilia Maria Perotti, Licia Mattioli, Silvia Merlo and Paolo Olivieri, are participating by means of telecommunication, whereas the Director Mr. Pietro Gussalli Beretta is justified absent;
- that from the Board of Statutory Auditors, the standing auditors, Messrs. Andrea Caretti (as Chairman), Margherita Spaini and Roberto Marrani are attending by means of telecommunications;
- that from the Independent Auditing Firm "BDO Italia S.p.A.", Mr. Paolo Maloberti is participating by means of telecommunications;
- that for "SPAFID S.p.A.", Mr. Michele Marveggio, as designated representative, and Mrs. Rosalba Pallotta, both Spafid employees, attended by means of telecommunications;
- that the following employees of the Company are attending in person, at the invitation of the Chairman: Attilio Abruzzese and Silvia Guidi;
- that the following consultants of the Company are attending by telecommunication means, at the invitation of the Chairman: Messrs. Toti Musumeci, Roberto Panero, Giovanni Faroti, Carlotta Pastore, Elodie Musumeci, Vittorio Squarotti, Leonardo Musumeci and Cesare Perotti;
- that the Ordinary Shareholders' Meeting was duly convened for today 21 April 2021, at thirty minutes after ten o'clock at the Company's offices in La Spezia, Viale San Bartolomeo 362, in first call, and if necessary, on 22 April 2021 at thirty minutes after ten o'clock, in second call, by means of notice of call published on 22 March 2021 on the Company's website, in the "Corporate Governance/Shareholders' Meeting" section and on the "[emarket storage](#)" authorised storage mechanism, announced in a press release and, in abstract form, in the daily newspaper "ilsole24ore", with the following

"1. Financial statements for the year ended 31 December 2020. Related and consequent resolutions:

1.1 approval of the financial statements and the report on operations for the year ended 31 December 2020. Presentation of the consolidated financial statements of the Sanlorenzo Group at 31 December 2020. Presentation of the non-financial statement for fiscal year 2020;

1.2 proposal for allocation of profit;

The Chairman announces that no requests for additions to the Shareholders’ Meeting agenda have been submitted by shareholders, nor there were any proposals for resolutions on items already on the agenda, in accordance with the provisions and deadlines indicated in Article 126-bis of the TUF. He reminds attendees that, as indicated in the notice of call, pursuant to Article 106 of the “*Cura Italia*” Decree and as an exception to the provisions of Article 10.4 of the By-laws, participation in the Shareholders’ Meeting by those entitled to vote is permitted exclusively through the Company’s designated representative, Spafid S.p.A., as the party to whom shareholders can grant proxies with voting instructions on all or some of the proposals on the agenda, pursuant to Article 135-undecies of the TUF, and that Spafid S.p.A., as designated representative, has announced that it has no personal interest in the proposed resolutions submitted for voting. However, with due consideration to the existing contractual relations between Spafid and the Company, particularly in relation to technical support at shareholders’ meetings and ancillary services, in order to avoid any subsequent disputes connected with presumed circumstances that may result in a conflict of interest as described in Article 135-decies, paragraph 2, letter f) of the TUF, Spafid has expressly stated that, should unknown events occur or in the case of amendments or supplements to the proposals presented to the Shareholders’ Meeting, it does not intend to cast a vote that differs from that indicated in the instructions.

The Chairman invites the designated representative to make any legal declaration required by law.

The appointed representative, Mr. Michele Marveggio, takes the floor and declares:

- that by the legal deadline, 152 (one hundred fifty-two) proxies for a total of 29,402,114 (twenty-nine million four hundred two thousand one hundred fourteen) ordinary shares, equal to 85.224% (eighty-five point two hundred twenty-four per cent) of the share capital, had been received;

- that prior to each vote, he will communicate the shares for which no voting indications have been provided by the delegating party.

The Chairman acknowledges that - pursuant to paragraph 3 of the aforementioned Article 135-undecies, shares for which proxy has been conferred, even partially, to the designated representative, are calculated for the purpose of duly constituting the Shareholders’ Meeting, while the shares for which voting instructions have not been provided for the proposals on the agenda will not be counted for the purposes of calculating the majority and the share capital required for approving related resolutions, and therefore declares that 152 (one hundred fifty-two) shareholders entitled to vote are attending via proxy, representing 29,402,114 (twenty-nine million four hundred two thousand one hundred fourteen) ordinary shares, equal to 85.224% (eighty-five point two hundred twenty-four per cent) of the share capital.

The Chairman informs that the communications of the intermediaries for purposes of participation in this Shareholders’ Meeting by the entitled persons through the designated representative were carried out in accordance with relevant governing legal provisions and in compliance with the provisions of the By-laws.

Hence, he declares that the Ordinary Shareholders' Meeting is duly convened, validly constituted in first call within the terms of the law and the By-laws and is empowered to make resolutions upon items on the agenda.

He announces that there was no solicitation of voting proxies pursuant to Article 136 *et seq.* of the TUF promoted in relation to today's meeting.

He informs that, pursuant to the "GDPR" (General Data Protection Regulation - EU regulation 2016/679) and the governing national legislation on personal data protection, the personal data collected are processed and stored by the Company, on electronic media and hardcopy, for the purposes of correctly conducting shareholders' meetings and for taking minutes, as well to satisfy any related corporate and legal obligations.

He also notes that the audio-video recording of the Shareholders' Meeting is made for the sole purpose of facilitating the taking of the meeting minutes and documenting what is transcribed in the minutes, as specified in the information provided to all participants; all data will be stored, together with the documents produced during the meeting, at Sanlorenzo's registered office; recording tools of any kind, photographic equipment and similar cannot be used, with the exception of the audio recording tools used by the Company to facilitate the taking of the meeting minutes.

The Chairman also declares that:

- the subscribed and paid-in share capital at today's date is **€34,500,000.00** (thirty-four million five hundred thousand/00) and is represented by **34,500,000** ordinary shares (thirty-four million five hundred thousand), without par value;
- to date, the Company holds no. 58,666 (fifty-eight thousand and six hundred sixty-six) treasury shares, whose voting rights is suspended according to Article 2357-*ter* of the Italian Civil Code;
- on 21 April 2020, the Shareholders' Meeting approved a divisible share capital increase, excluding option rights, pursuant to Article 2441, paragraph 8 of the Italian Civil Code, of a maximum nominal value of €884,615.00 (eight hundred eighty-four thousand six hundred fifteen/00), to be executed no later than 30 June 2029, through the issue of a maximum number of 884,615 (eight hundred and eighty-four thousand six hundred and fifteen) ordinary shares of Sanlorenzo destined, exclusively and irrevocably, to service the 2020 Stock Option Plan, as approved by the Sanlorenzo Extraordinary Shareholders' Meeting of 21 April 2020, all under the terms and conditions set out in the resolution;
- each ordinary share provides the right to one vote at the Shareholders' Meeting;
- to date there are no shares that have accrued the right to increase voting rights;
- the Company's shares are admitted for trading on the electronic stock market organised and managed by Borsa Italiana S.p.A. - Star segment;

He recalls that:

- Consob, most recently with resolution no. 21672 of 13 January 2021, approved to extend for a three-month period, from 14 January 2021 until 13 April 2021, unless revoked early, the provisions relating to the identification of further thresholds for the disclosure of company shareholdings and declarations of intent – as set out in resolution no. 21326 and no. 21327 of 9 April 2020, adopted pursuant to Article 120, paragraph 2-*bis* and 4-*bis* respectively, of the TUF, as already extended by effect of resolution no. 21434

of 8 July 2020 and no. 21525 of 7 October 2020 – in companies with a shareholder base particularly widespread, including Sanlorenzo,

- on 12 April 2021, Consob has subsequently notified not to further extend the temporary regime of enhanced transparency introduced on 9 April 2020, and hence, from 14 April 2021 only the ordinary legislation on transparency regarding changes of significant equity investments and declarations of investment objectives has come back into force;
- to date, according to the findings of the Company's shareholders' register, supplemented by additional notifications received pursuant to Article 120 of the TUF and other available information, the parties that hold, directly or indirectly, **an equity investment exceeding 3% (three per cent) of the subscribed share capital** of Sanlorenzo S.p.A., represented by shares with voting rights, are the following:

The Chairman notes:

- that the voting rights relating to the shares for which the disclosure obligations referred to in Articles 120 and 122, paragraph 1, of the TUF - concerning respectively the significant equity investments and shareholders' agreements - have not been fulfilled, cannot be exercised;
- that the Company is not aware of any shareholders' agreements stipulated between shareholders;
- that the designated representative has declared that he will vote on the basis of the instructions provided by the delegating parties;
- that, with regard to the items of the agenda, the requirements envisaged by governing laws and regulations have been duly fulfilled;
- the related documentation has been subject to disclosure obligations contemplated by the applicable regulation, as well as made available on the Company's website;
- that the following are attached to the meeting minutes as an integral and essential part of the same and will be available to those entitled to vote:
 - the list of names of the participants in the Shareholders' Meeting, through the designated representative, complete with all the data required by Consob, indicating the number of shares for which the communication by the intermediary to the issuer has been made, pursuant to Article 83-*sexies* of the TUF (**ATTACHMENT A**);
 - the list of names of the persons who have expressed, through the designated representative, a vote in favour or against, or have abstained, and the relative number of shares represented by him/herself and/or by proxy (**ATTACHMENT B**);
- that the Company has not received any questions prior to the Shareholders' Meeting within the deadline of 12 April 2021 indicated in the notice of call, in accordance with the provisions of Article 127-*ter* of the TUF.

The Chairman of the Board of Statutory Auditors then takes the floor and declares that he has verified and can ensure, with reference to the issue by the Company of proxies to the designated representative, the confidentiality by the designated representative of the voting instructions up to the beginning of voting in the Shareholders' Meeting.

The Chairman then moves on to discussion of the **first item** on the agenda:

1. Financial statements for the year ended 31 December 2020. Related and consequent resolutions:

1.1 approval of the financial statements and the report on operations for the year ended 31 December 2020. Presentation of the consolidated financial statements of the Sanlorenzo Group at 31 December 2020. Presentation of the non-financial statement for fiscal year 2020;

1.2 proposal for allocation of profit;

1.3 restriction on the extraordinary reserve up to a maximum amount of €8,400,000 pursuant to Article 110, paragraph 8, of Italian Legislative Decree no. 104 of 14 August 2020, converted into law, as amended, by Law no. 126 of 13 October 2020.

The Chairman specifies that the reading of the documents will be omitted, limiting the reading to the resolution proposals only. The same procedure will also be applied to all other items on the agenda for today's Ordinary Shareholder's Meeting. The Chairman acknowledges that there are no objections.

At this point, the Chairman states that, considering that the figures from the separate and consolidated financial statements as at 31 December 2020, as well as the non-financial statement for fiscal year 2020, as examined and approved by the Company's Board of Directors held on 16 March 2021, were made available to the public in accordance with the law, their presentation can be omitted. The Chairman acknowledges that there are no objections.

The Chairman summarises the main data of the consolidated financial statements as at 31 December 2020 and of the non-financial statement for fiscal year 2020.

In view of the foregoing, the following proposed resolution is submitted for approval of the Shareholders' Meeting:

"The Shareholders' Meeting of Sanlorenzo S.p.A., convened in ordinary session,

- (i) having heard and approved the presentation of the Board of Directors;*
- (ii) having examined the draft financial statements of Sanlorenzo S.p.A. as for the year ended 31 December 2020, which highlight a net profit for the year equal to €33,997,047, and the Explanatory Report of the Board of Directors and the proposals contained therein;*
- (iii) having examined the non-financial statement for fiscal year 2020;*
- (iv) having noted the report of the Board of Statutory Auditors and the report of the Independent Auditors*

resolves

1. to approve the financial statements of Sanlorenzo S.p.A. for the year ended 31 December 2020 and the Report of the Board of Directors on Operations;

2. to allocate the net profit for the year, totalling €33,997,047, (i) to cover losses for previous years due to the adoption of IFRS accounting standards, €20,147; (ii) to the legal reserve, €1,698,845; (iii) to the Shareholders as

dividend in the amount of €0.30, gross of withholding tax, for each of the shares in circulation on the ex-dividend date, excluding treasury shares held at that date, with payment date on 28 April 2021, ex-dividend date on 26 April 2021 and record date (date of entitlement to the dividend payment, pursuant to Article 83-terdecies of the Italian Legislative Decree no. 58 of 24 February 1998) on 27 April 2021; (iv) to the extraordinary reserve, the residual profit;

3. to put a restriction on the extraordinary reserve up to a maximum amount of €8,400,000 pursuant to Article 110, paragraph 8, of Italian Legislative Decree no. 104 of 14 August 2020, converted into law, as amended, by Law no. 126 of 13 October 2020;

4. to confer on the Chairman of the Board of Directors Massimo Perotti, the right to sub-delegate, including through powers of attorney, the broadest powers to carry out all the activities relating to, consequent to or connected with the implementation of the resolutions referred to in points 1), 2) and 3) above.”

Mr. Andrea Caretti, Chairman of the Board of Statutory Auditors, takes the floor and reads the concluding remarks from the report of the Board of Statutory Auditors on the 2020 financial statements of Sanlorenzo S.p.A.

After hearing the report, the Chairman, Massimo Perotti, puts the proposed resolution concerning the approval of the financial statements of Sanlorenzo S.p.A. for the year ended 31 December 2020 and the Report of the Board of Directors on Operations to the vote.

He asks the designated representative, pursuant to Article 135-undecies of the TUF and for the purpose of calculating majorities, whether in relation to the proposal read previously he is in possession of voting instructions for all the shares covered by proxy.

Following the response of the designated representative, the Chairman specifies that 152 (one hundred fifty-two) shareholders entitled to vote are attending via proxy, representing 29,402,114 (twenty-nine million four hundred two thousand one hundred fourteen) ordinary shares, equal to 85.224% (eighty-five point two hundred twenty-four per cent) of the share capital.

Voting continues through announcement of the votes by the designated representative.

The Chairman submits, for the approval, the remuneration policy pursuant to Article 123-ter, paragraphs 3-bis and 3-ter of the TUF and he invites to pass a resolution on the "Second Section" of the report on the policy regarding remuneration and fees paid, pursuant to Article 123-ter, paragraph 6 of the TUF.

He notes that this report, prepared pursuant to Article 125-ter of the TUF and Articles 72 and 84-ter of Consob Regulation No. 11971 of 14 May 1999 (the "Issuers' Regulation"), was approved by the Board of Directors of the Company held on 16 March 2021 and made available to the public as required by law.

Therefore, he moves on to discuss the **first sub-item**:

2.1 Approval of the remuneration policy pursuant to Article 123-ter, paragraphs 3-bis and 3-ter of Italian Legislative Decree No. 58 of 24 February 1998.

Pursuant to the aforementioned legislation, this Shareholders' Meeting is called to resolve upon the first section of the Report in favour or against and to approve the policy on the remuneration of executive directors, general managers, executives with strategic responsibilities and, without prejudice to the provisions of Article 2402 of the Italian Civil Code, the members of the Company's control body, presented therein. The resolution is binding.

The Chairman, on behalf of the whole Board of Directors therefore submits the following motion for your approval.

Proposed resolution

"The Ordinary Shareholders' Meeting of Sanlorenzo S.p.A.,

(i) having heard and approved the presentation of the Board of Directors;

(ii) having examined the Explanatory Report of the Board of Directors and the proposals contained therein;

(iii) having shared the reasons for the proposals contained therein, pursuant to Article 123-ter, paragraphs 3-bis and 3-ter of Italian Legislative Decree No. 58 of 24 February 1998 and by operation of law and regulation, and hence with binding resolution, in a favourable sense on the first section of the Company Report on the policy regarding remuneration and fees paid and to approve the policy on the remuneration of the members of the administrative bodies, general managers and executives with strategic

Following the response of the designated representative, the Chairman specifies that 152 (one hundred fifty-two) shareholders entitled to vote are attending via proxy, representing 29,402,114 (twenty-nine million four hundred two thousand one hundred fourteen) ordinary shares, equal to 85.224% (eighty-five point two hundred twenty-four per cent) of the share capital.

Voting continues through announcement of the votes by the designated representative.

- in favour: 28,551,132 votes equal to 97.16% of the share capital participating in the vote;
- against: 850,982 votes equal to 2.894% of the share capital participating in the vote;
- abstained: zero votes equal to 0% of the share capital participating in the vote;
- not voting: zero votes equal to 0% of the share capital participating in the vote.

The proposal is approved, all in accordance with the details provided in **ATTACHMENT B**.

The Chairman asks the designated represented, pursuant to Article 134 of the Issuers' Regulation, if he expressed any votes not compliant with the instructions received. The designated represented answered no.

Therefore, he moves on to discuss the **second sub-item**:

2.2 Resolution on the "Second section" of the report on the policy regarding remuneration and fees paid, pursuant to Article 123-ter, paragraph 6 of Italian Legislative Decree No. 58 of 24 February 1998.

Pursuant to the aforementioned legislation, this Shareholders' Meeting is called to resolve upon the second section of the Report in favour or against. The resolution is not binding.

The Chairman, on behalf of the whole Board of Directors therefore submits the following motion for your approval.

Proposed resolution

"The Ordinary Shareholders' Meeting of Sanlorenzo S.p.A.,

(i) having heard and approved the presentation of the Board of Directors;

(ii) having examined the Explanatory Report of the Board of Directors and the proposals contained therein;

(iii) having shared the reasons for the proposals contained therein

resolves

pursuant to Article 123-ter, paragraph 6 of Italian Legislative Decree No. 58 of 24 February 1998 and by operation of law and regulation, and hence with non-binding resolution, in a favourable sense on the second section of the Company Report on the policy regarding remuneration and fees paid."

The Chairman, Mr. Massimo Perotti, puts the proposed resolution read previously to the vote, asking the designated representative, pursuant to Article 135-*undecies* of the TUF and for the purpose of calculating majorities, whether in relation to the proposal read previously he is in possession of voting instructions for all the shares covered by proxy.

Following the response of the designated representative, the Chairman specifies that 152 (one hundred fifty-two) shareholders entitled to vote are attending via proxy, representing 29,402,114 (twenty-nine million four hundred two thousand one hundred fourteen) ordinary shares, equal to 85.224% (eighty-five point two hundred twenty-four per cent) of the share capital.

Voting continues through announcement of the votes by the designated representative.

- in favour: 23,979,753 votes equal to 81.558% of the share capital participating in the vote;
- against: 5,422,361 votes equal to 18.442% of the share capital participating in the vote;
- abstained: zero votes equal to 0% of the share capital participating in the vote;
- not voting: zero votes equal to 0% of the share capital participating in the vote.

The proposal is approved, all in accordance with the details provided in **ATTACHMENT B**.

The Chairman asks the designated represented, pursuant to Article 134 of the Issuers' Regulation, if he expressed any votes not compliant with the instructions received. The designated represented answered no.

There being no other matters to be resolved and as none of the attendees have requested the floor, the Chairman, after being empowered by the Shareholders' Meeting to make all amendments, suppressions and additions to this document as deemed necessary for its entry in the Register of Companies, thanks the attendees, steps down from the chair and closes the Shareholders' Meeting at twenty-five minutes after eleven o'clock.

All costs with regard to this deed and related expenses will be borne by the Company.
