Milan, 03 June 2021 – Giglio Group S.p.A. (Ticker GG) informs that, with regard t the presentation of the slates for the renewal of the Board of Statutory Auditors (item no. 4 on the agenda of the ordinary part of the Shareholders' Meeting called for 21 June 2021), only one slate was presented within the deadline set.
