#### **AEFFE: Notification Of Share Buy-Back From 7<sup>th</sup> To 11<sup>th</sup> June 2021**

**San Giovanni in Marignano, 14 June 2021** – Aeffe SpA announces to have acquired from 7<sup>th</sup> to 11<sup>th</sup> June 2021, in conforming with the programme released to the market and approved by the Shareholders' meeting held on April 28, 2021, a total number of 15,000 treasury shares (corresponding to 0.014% of the total number of the ordinary shares), at weight average price of Euro 1,744 for a total countervalue of Euro 26,160.00.

The Company, listed on the STAR segment of Borsa Italiana, operates in the luxury sector, with a presence in the prêt-à-porter, footwear and leather goods division under renowned brand names such as Alberta Ferretti, Philosophy di Lorenzo Serafini, Moschino and Pollini.

On the basis of the information provided by Banca Imi S.p.A., the authorized intermediary in charge of carrying out the purchases of treasury shares, the daily transactions made are summarized below in aggregate form:
