Milan, June 29th, 2021 – COIMA RES announces that, today, has been published on the website www.coimares.com (in the Governance / Related Parties Transactions section) the new procedure on transactions with related parties, as approved by the Board of Directors on June 10th, 2021, on the back of a favourable opinion of the Related Parties Committee, reflecting the new provisions of Consob Regulation no. 17221/2010, as most recently amended by Consob Resolution no. 21624 of December 10th, 2020.
