("**AIM Italia**"), as part of the buy-back program approved by the shareholders' meeting of December 30, 2020, in the period from 5th July 2021 to 9th July 2021, the purchase of a total of no. 18,900 ordinary shares for a total value of Euro 50,767.50.

The purchases were made with the coordination of BPER Banca S.p.A., an intermediary entrusted with full independence and autonomy for the implementation of the program for the purchase of ordinary treasury shares.
