COMMUNICATION OF CHANGES TO THE EL.EN.'S SHARE CAPITAL

Firenze, July 9th, 2021 - El.En. SpA, leader on the laser market and listed on the Italian Stock Exchange managed by Borsa Italiana, hereby gives notice of the changed amount of its share capital pursuant to art. 85-bis Consob Issuers' Regulation.

Following the exercise by some of the beneficiaries of the 2016-2025 Stock Option Plan approved by the Board of Directors on September 13th, 2016 of the options assigned to them for the subscription of newly issued ordinary shares, the company issued in the period included between June 18th, 2021 and July 8th, 2021, n. 2.400 ordinary shares for an amount of nominal euro 312,00.

Therefore, as of July 8th, 2021 the El.En.'s share capital amounts to euro 2.590.846,18 equal to n. 19.929.586 ordinary shares.

Today the certificate of the share capital increase has been filed with the Companies House.
