SECO posts all-time monthly order intake record: over Euro 20 million new orders in July

Arezzo, August 2, 2021 – SECO, reference player in the field of technological innovation and Internet of Things solutions, announces its all-time record of monthly order intake: in July, the new backlog generated in the month hit a level of over Euro 20 million.

Fully deriving from organic growth, approximately 37% of new orders came from clients based in the USA, while EMEA contributed for 59%, and APAC and Emerging Markets jointly added the remaining 4%. Included in this amount is the order worth Euro 2.5 million received from Airtame and communicated on July 22.

In addition, over Euro 1 million of new backlog (i.e. more than 5% of total incremental orders) derives from the Software-as-a-Service business powered by SECO Mind.

"We reached an extraordinary result, proving by facts the effectiveness of SECO's strategy and winning positioning. This is also confirmed by the progressive increase of the SaaS business component on our total mix. SECO still has a lot of unexpressed potential and I am highly enthusiastic and positive on our future", **said** *Massimo Mauri, SECO CEO.*
