MERGER BY INCORPORATION OF ABC ASSICURAZIONI AND BERICA VITA IN CATTOLICA ASSICURAZIONI

Verona, 6 August 2021. Following what was already communicated on 21 July 2021, and having the deadline set out in art. 2505, last paragraph, of the Civil Code, expired without the shareholders having requested to call the shareholders' meeting on the decisions regarding the mergers, we inform you that the Board of Directors of the Company, which met yesterday under the chairmanship of Davide Croff, approved the merger by incorporation of ABC Assicura SpA and Berica Vita S.p.A. in Cattolica Assicurazioni¹.

The relative resolutions are being filed and registered with the competent Verona company register and will in any case be subject to forthcoming publication within the terms of the law.

Cattolica Assicurazioni is one of the main players in the Italian insurance industry and has been listed on the Milan Stock Exchange since November 2000.
