UPDATE ON THE SHARE BUY-BACK PROGRAM

Milan, August 23rd, 2021 – In relation to the share buy-back program resolved by the Shareholders' Meeting of April 23rd, 2021, Amplifon (MTA; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period 16th - 17th August, 2021, a total of 60,000 ordinary Amplifon S.p.A. shares, equivalent to 0.027% of the share capital, at an average unit price of Euro 42.997 per share, for a total consideration of Euro 2,579,815.80.

On the basis of information provided by the intermediary agent appointed for the implementation of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

In reference to the same resolution, the Company has used treasury shares to service the Performance Stock Grant Plan 2011-2020 and Performance Stock Grant Plan 2014-2021 for a total of n. 13,506,895 shares.

As of August 20th, 2021, Amplifon owns n. 1,638,905 of its shares, corresponding to 0.724% of the Company's share capital and to 0.507% of the total share capital in voting rights.
