Reggio Emilia, 8 October 2021 – Newlat Food S.p.A. (the “**Company**” or “**Newlat Food**”) announces that, following the authorization of the purchase and disposal of own shares by the Shareholders’ Meeting of 29 April 2021, in the period from 3 September to 30 September 2021, the Company bought back a total of 120,920 ordinary shares on the Mercato Telematico Azionario (equal to 0.28% of the share capital) at an average share price of € 6.57 and for a total value of € 794,575.20.
