Servizi Italia S.p.A. informs that, in the period between 11 October and 15 October 2021 the Company bought on the Milan Stock Exchange, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2021 (previously communicated as per Art. 144 bis of Consob regulation 11971/1999), n. 8,000 ordinary shares (corresponding to 0.025% of the Company's share capital) at an average price of Euro 2.1389 per share, for a total of Euro 17,111.10.
