CLOSING OF THE ACQUISITION OF BOREUS GMBH AND GECKO GESELLSCHAFT COMPUTER UND KOMMUNIKATIONSSYSTEME M.B.H.

Milano, 2 November 2021 – Following the disclosure to the market on 18 October 2021, WIIT S.p.A. ("WIIT" or the "Company"), a leading European player in the Cloud Computing market of enterprises demanding uninterrupted Hybrid Cloud and Hosted Private Cloud services for critical applications and listed on the Euronext STAR Milan segment, announces that today the acquisition of 100% of the share capital of Boreus GmbH ("Boreus") and Gecko Gesellschaft für Computer und Kommunikationssysteme m.b.H ("Gecko") has been consummated in execution of the agreements signed on 18 October 2021. The price for the two acquisitions has been identified in the overall approximate amount of Euro 77.7 million, of which about Euro 59.8 million for the acquisition of Boreus (partly paid through WIIT shares for a corresponding amount of Euro 10 million) and about Euro 18 million for the acquisition of Gecko, without prejudice to the price adjustment mechanisms and, more generally, the main terms and conditions of the transaction already described in the press release of 18 October 2021 to which reference is made.

The acquisition of Boreus (cloud provider) and Gecko (developer of DevOps software solutions with a focus on kubernetes technologies) represents, after myLoc, occurred at the end of 2020, and Mivitec, occurred in July 2021, a further and significant step of the Cloud4Europe project launched by the Group in line with its external growth strategies.
