Florence, December 13, 2021 – With reference to the plan for purchasing treasury shares passed by the Shareholders' Meeting held in ordinary session on April 22, 2021, whose launch has been also resolved by the Board of Directors held on September 7, 2021, as communicated to the market on the same date according to article 144-bis of the Consob Regulation adopted with resolution no. 11971/1999, Salvatore Ferragamo S.p.A. (MTA: SFER), parent company of the Salvatore Ferragamo Group, announces that it has purchased on the Italian Equities Market (MTA) organized and managed by the Italian stock market Borsa Italiana S.p.A. on 10 December 2021 no. 27.000 Salvatore Ferragamo S.p.A.'s ordinary shares (ISIN code: IT0004712375), equal to 0,02% of the share capital, at an average unit price of Euro 22,73682 per share, for a total countervalue equal to Euro 613.894,14.

On the basis of information provided for by the entrusted intermediary, below there is a summary of daily purchase transactions made on the MTA – Italian Equities Market, in aggregate form:
