Servizi Italia S.p.A. informs that, in the period between 09 May and 13 May 2022 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2021 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 8,400 ordinary shares (corresponding to 0.026% of the Company's share capital) at an average price of Euro 1.7573 per share, for a total of Euro 14,761.65.
