# Servizi Italia: notification of share buy-back period 23 May – 27 May 2022

Servizi Italia S.p.A. informs that, in the period between 23 May and 27 May 2022 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2021 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 14,758 ordinary shares (corresponding to 0.046% of the Company's share capital) at an average price of Euro 1.6026 per share, for a total of Euro 23,651.91.
