UPDATE ON THE SHARE BUYBACK PROGRAM

Milan, May 30th, 2022 – In relation to the share buyback program resolved by the Shareholders' Meeting of April 22nd, 2022, Amplifon (EXM; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period May 23rd - 26th, 2022, a total of I60,000 ordinary Amplifon S.p.A. shares, equivalent to 0.071% of the share capital, at an average unit price of Euro 32.050 per share, for a total consideration of Euro 5,127,925.20.

On the basis of information provided by the intermediary agent appointed for the implementation, in full independence, of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

In reference to the same resolution, the Company has used treasury shares to service the Performance Stock Grant Plan 2011-2020 and Performance Stock Grant Plan 2014-2021 for a total of n. 13,786,133 shares.

As of May 26th, 2022, Amplifon owned n. 2,559,367 of its shares, corresponding to I.I31% of the Company's share capital and to 0.793% of the total share capital in voting rights.
