## PRESS RELEASE

### CONSENSUAL AND EARLY TERMINATION OF THE AGREEMENT SIGNED WITH EDOARDO POZZOLI ON 30 MARCH 2020

Reggio Emilia, 28 June 2022 - Newlat Food S.p.A. (the "**Company**" or "**Newlat Food**") announces that it has terminated by mutual agreement and in advance, with effect from 1 July 2022, the agreement signed on 30 March 2020 with Mr. Edoardo Pozzoli (the "**Agreement**"), regarding no. 6,660,242 shares of Centrale del Latte d'Italia S.p.A. ("**CLI**"), constituting 47.573% of the share capital and 41.507% of the total voting rights.

From that date, the Agreement is understood to be ineffective between the parties, who are, therefore, definitively and irrevocably released from all commitments and obligations deriving from it.

The news relating to the dissolution of the Agreement will be made available in the manner and within the terms set out in Articles 129 and 131, paragraph 4, of the Regulation adopted with CONSOB resolution no. 11971 of 1999.
