Servizi Italia S.p.A. informs that, in the period between 4 July and 8 July 2022 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2021 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 3,712 ordinary shares (corresponding to 0.012% of the Company's share capital) at an average price of Euro 1.3854 per share, for a total of Euro 5,142.74.
