### VARIATION OF CORPORATE EVENTS CALENDAR

Verona, 11 July 2022. In light of what was communicated by Assicurazioni Generali S.p.A. on 08.07.2022 with reference to the publication of the information document relating to the purchase obligation procedure pursuant to art. 108, paragraph 2, of Legislative Decree no. 58 of February 24, 1998, as subsequently amended, on the ordinary shares of Cattolica Assicurazioni S.p.A. and having regard to the terms indicated therein for carrying out the procedure for the sale of the shares, considering the possibility that, upon the outcome of the aforementioned procedures, the shares will be withdrawn from the stock market listing, the Company announces the postponement of the reporting date previously communicated to the market for the approval of the consolidated half-yearly financial report from 28 July 2022 to 22 September 2022.
