CLOSING SHARE PRICE AT EUR 2.85, UP 18.75% ON THE OFFERING PRICE

S. Angelo di Piove di Sacco (PD), August 1st, 2022 – [Energy S.p.A.](#), a company offering integrated Energy Storage Systems, announces today the start of trading of its ordinary shares (ISIN code: IT0005500712 and Ticker ENY) on Euronext Growth Milan (EGM), a multilateral trading facility organised and managed by Borsa Italiana S.p.A. dedicated to small and medium-sized companies with high growth potential.

The share recorded an opening price of Euro 2.72 and closed today's session at a price of Euro 2.85, up 18.75% on the placement price of Euro 2.40 per share. On the first day, 283,500 shares were traded for a value of Euro 786,565.
