Servizi Italia S.p.A. informs that, in the period between 22 August and 26 August 2022 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2021 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 5,500 ordinary shares (corresponding to 0.017% of the Company's share capital) at an average price of Euro 1.2599 per share, for a total of Euro 6,929.19.
