### Director resignation

**Milan, August 29, 2022** - WIIT S.p.A. As of the resignation date, Mr. Dario was not a member of any internal board committee. It is also confirmed that there are no indemnities or other benefits payable as a result of his conclusion of office.

WIIT expresses its heartfelt thanks to Mr. Dario for his hard work and commitment in executing the role.

The Board of Directors meeting of the Company scheduled for September 13, 2022 to approve the consolidated half-year financial report at June 30, 2022 shall appoint a new board member by co-optation to replace Mr. Dario.
