Servizi Italia S.p.A. informs that, in the period between 26 September and 30 September 2022 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2021 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 8,500 ordinary shares (corresponding to 0.027% of the Company's share capital) at an average price of Euro 1.0522 per share, for a total of Euro 8,943.96.
