## BUYBACK PROGRAM

### Update on the buyback program on Equita Group S.p.A. shares

Milan, October 10, 2022

Equita Group S.p.A. ("Equita"), with reference to the authorization resolved by the Shareholders' Meeting on 28 April 2022, hereby announces that, during the period from October 3<sup>rd</sup>, 2022 to October 7<sup>th</sup>, 2022 included, purchased on the Euronext STAR Milan no. 4,827 treasury shares, equal to 0.0095% of the share capital, at the average price of €3.1962 per share, for a total consideration of €15,427.97.

In accordance with Article 2, paragraph 3 of the Delegated Regulation (EU) 2016/1052, attached the detailed list of purchases made on ordinary shares Equita, ISIN code IT0005312027, in the aforementioned period, based on the information provided by the intermediary in charge of the execution of the buyback program.

Since the beginning of the program, Equita has purchased No. 11,688 ordinary shares (equal to 0.0230% of the share capital), for a total consideration of €37,087.06.

Following the above purchases and considering the treasury shares already in portfolio, as of October 7<sup>th</sup>, 2022 Equita holds no. 4,051,490 treasury shares, equal to 7.9742% of the share capital.
