# UPDATE ON THE SHARE BUYBACK PROGRAM

Milan, November 3<sup>rd</sup>, 2022 – In relation to the share buyback program resolved by the Shareholders' Meeting of April 22<sup>nd</sup>, 2022, Amplifon (EXM; Bloomberg ticker: AMP:IM), the global leader in hearing solutions and services, announces that it has purchased in the period October 28<sup>th</sup> – November 2<sup>nd</sup>, 2022, a total of I60,000 ordinary Amplifon S.p.A. shares, equivalent to 0.071% of the share capital, at an average unit price of Euro 24.927 per share, for a total consideration of Euro 3,988,245.20.

On the basis of information provided by the intermediary agent appointed for the implementation, in full independence, of the share buy-back program, here below the details of the share purchase transactions on the MTA on daily basis:

In reference to the same resolution, the Company has used treasury shares to service the Performance Stock Grant Plan 20II-2020 and Performance Stock Grant Plan 20I4-202I for a total of n. I4,640,845 shares.

As of November 2<sup>nd</sup>, 2022, Amplifon owned n. I,827,I55 of its shares, corresponding to 0,807% of the Company's share capital and to 0.566% of the total share capital in voting rights.
