COMMUNICATION ON TOTAL AMOUNT OF VOTING RIGHTS pursuant to Article 85-bis, paragraph 4-bis, of Consob Regulation no. 11971/1999

Saluggia, November 7th, 2022 – DiaSorin S.p.A. (“DiaSorin” or the “Company”) hereby announces that today three shareholders, holding equity interests lower than 3% of the overall voting rights – having fulfilled the requirements and conditions under the applicable regulation and the Company By-Laws – obtained the assignment of increased voting rights (based on the ratio of two votes for each share) for overall no. 51,225 ordinary shares of the Company.

It is also announced that three shareholders, holding equity interests lower than 3% of the overall voting rights, waived to the increased voting rights already accrued for overall no. 38,772 ordinary shares of the Company.
