*Following the Board of the Directors' meeting the Company will arrange a dedicated conference call for financial analysts and institutional investors.

Starting from the financial year 2023, otherwise than up to the current financial year, with reference to the financial information as at 31 March and 30 September, the Company will only provide the following information to the public:

- the consolidated sales revenues as at 31 March, by 30 April; and
- the consolidated sales revenues as at 30 September, by 30 October.
