Milan, December 27, 2022 – Further to that communicated on December 20, 2022, WIIT S.p.A. ("WIIT" o la "Company") announces that on December 23, 2022, the resolution of the Company's Board of Directors which - pursuant to Article 2505, paragraph 2, of the Italian Civil Code and Article 16, paragraph 2, of the Articles of Association - approved the merger of the wholly owned subsidiary Erptech S.p.A. into WIIT (the "Merger") was registered with the competent Companies Register.
