Issue of the "Euro 20,000,000.00 - Annual Variable Rate Euribor 3-month plus 2.78% maturing December 29, 2026" bond

Milan, December 29, 2022 - WIIT S.p.A. ("**WIIT**" or the "**Company**") announces that today it issued bonds related to a non-convertible, unsubordinated and unsecured bond with a total nominal value of Euro 20,000,000.00, approved by the Board of Directors of the Company on December 20, 2022, and named "Euro 20,000,000.00 - Annual Variable Rate 3-month Euribor plus 2.78% maturing on December 29, 2026" (the "**Bond**").

The Bond was underwritten by Mortirolo BB SPV S.r.l. (the "**SPV**"), a securitization special purpose vehicle, as part of a "basket bond" transaction supported by the European Investment Bank ("**EIB**") through an on-demand guarantee under a guarantee agreement named "*Italy EGF SMEs and MidCaps Basket Bond Framework Guarantee Agreement*" signed on December 20, 2021 (as amended) between Cassa Depositi e Prestiti S.p.A. ("**CDP**") and the EIB.

The SPV funded the payment of the subscription price of the Bond through the issue, by the SPV, as per Law No. 130 of April 30, 1999, on securitization, of "asset-backed partly-paid" securities underwritten by CDP and BPER Banca S.p.A. ("**BPER**").
