Upon publication of the annual results for the year 2022, as well as the half-year and interim results for 2023, Aquafil will hold ad-hoc conference calls to present the relevant Group's accounting data to financial analysts and institutional investors.

The polymers produced from ECONYL® caprolactam are distributed to the Group's production plants, where they are transformed into yarn for rugs carpet flooring and for clothing. Founded in 1965, Aquafil is one of the main producers of nylon in Italy and worldwide. The Group employs over 2,800 people, at 19 production sites located in nine countries and in four different continents, more precisely in Italy, Slovenia, Unites States, China, Croatia, Scotland, Thailand, Australia and Japan.
