Authorised by Monza Brianza Province the construction of a new treatment and recovery plant

The Plant will provide significant environmental benefits with a capacity of 50 thousand tons of non hazardous industrial waste per year

**Milan, 31 January 2023**. **Innovatec S.p.A.**, listed on the Euronext Growth Milan market, announces that its subsidiary Green Up S.p.A. ("**Green Up**") - active in the Environment and Circular Economy business - has received authorisation from the Province of Monza Brianza to build a brand new waste treatment and recovery plant in Lazzate.

The plant, which will provide significant environmental benefits by reducing the amount of waste destined for final disposal, will have an authorised capacity for the treatment of 50 thousand tons of non hazardous industrial waste per year, will be fully automated, and will be equipped with the most advanced technologies available on the market for carrying out this activity.

The authorised plant is immediately ready for construction, will extend over an area of about 13,000 square metres, 3,000 of which will be covered, and will be built in the next twelve months with an expected investment of about EUR 3.5 million.

**Flavio Raimondo, Sole Director of Green Up S.p.A.**, commented: "We are particularly satisfied with the fruitful cooperation with the institutions and all the authorities involved, which has made it possible to obtain authorisation for this plant, which is of great value for the area as it allows for a virtuous and sustainable waste management cycle". "The start-up of this new plant, added Flavio Raimondo, represents an important step for Green Up and the Innovatec Group to goal the 2022-2024 Development Plan targets in the waste treatment and circular economy sector."
