AGREEMENT WITH INTESA SANPAOLO ON THE TRANSFER OF TAX CREDITS AMOUNTING TO EURO 600 MILLION

Milan, 27 February 2023 – Openjobmetis S.p.A. (Borsa Italiana: **OJM**), one of the leading employment agencies, listed on the STAR segment of Euronext Milan and operated by Borsa Italiana, signed an agreement with Intesa Sanpaolo for the **transfer of tax credits** amounting to Euro 600 million.

The agreement reached between Openjobmetis S.p.A and Intesa Sanpaolo allows for the full implementation of the "Decreto Aiuti" (Aid Decree), which provides for the possibility of transfer for the business world.

Therefore, Openjobmetis S.p.A is actively contributing to the recovery of the credit transfer market, helping many companies in the construction sector and households in difficulty due to the block of credit transfers.

The Managing Director Rosario Rasizza commented, *"We are pleased to announce the partnership with Intesa Sanpaolo, the first bank to announce operations in this area. This agreement places us at the forefront of concrete support for people and local communities, confirming our ability to always act in close synergy with the context in which we operate"*.

Openjobmetis - an overview: Openjobmetis is the Employment Agency established in 2011 as a result of the merger of Openjob SpA and Metis SpA, combining the unique skills and experiences for which they have always been known. Listed since December 2015, Openjobmetis SpA is the first and only Employment Agency in the STAR segment of Euronext Milan (EXM) operated by Borsa Italiana, and is positioned among the leading Italian operators in its field, with revenue of approximately EUR 720,8 million in the year ended 31 December 2021. Openjobmetis SpA, which provides temporary work employment, operates through a network of 150 branches and Specialized Divisions in a wide range of labour market sectors, including: Healthcare, Banking and Finance, Large-Scale Retail Trade, Big Clients, I&CT, Agro-Industrial and, as well as Techne specialized in aerospace, naval and energy thanks to the acquisition of Quanta S.p.A., a company merged into Openjobmetis with effect from 1 January 2022. Among the services offered, there are also research and selection solutions for direct entry into a company of qualified junior profiles through the Permanent Placement team and the division UNA Forza Vendite which deals with commercial figures and sales agents

Openjobmetis also has the following subsidiaries: (i) Openjob Consulting Srl, active in the management of the financed training activities; (ii) Seltis Hub Srl, the highly specialized vertical competence center focused on recruitment and selection that also operates through the digital platforms Meritocracy and Jobmetoo, (iii) Family Care Srl, APL dedicated to family assistance. Finally (iv) HC Srl, a result of the merger of Corium Srl and HC Srl, 92.9% owned, which deals with training, coaching and outplacement and (v) Lyve Srl, a 50.66% subsidiary, a training company specialized in the field of financial and insurance services.
